<u>Presentation – HPD and Habitat for Humanity:</u>

- The project aims to create permanently affordable ownership through a community land trust and includes sustainable energy systems.
- Habitat for Humanity leads the development, emphasizing community engagement and training for future homeowners.
- The proposed units will be affordable for households earning 70% to 80% of the area median income (AMI).
- The site is currently vacant land, not a park.
- Habitat NYC has begun outreach to nearby residents regarding construction plans.
- The project involves two clusters: Mosaic (13 sites) and Constellation (8 sites), with varying unit sizes.
