Donnette Riker Sareve The General Community Board meeting was called to order by the Chair of the Board, Ms. Joan Bakiriddin:

## **Chairperson's Report:**

- Attended the Funeral of Kate Ashton Tylor Lewin, 12 year old murdered in the community
- City Planning released an equitable development data tool that can be used to assist with facilitating difficult conversations about housing. The Commissioner is available to attend CB17 Land Use meeting to make a presentation.
- Heat Flash cool Smart Brooklyn group that presented at the Borough Board meeting. The program is funded by the Borough President and a New York State energy research and development authority that address climate change.
- In response to the February resolution,. A rezoning Town Hall meeting, via WebEx is planned for Saturday, April 16 and Friday6 April 29th. Land Use Chair will give an update on the 1st rezoning
- CB17 Election Committee selected to start the election process. Ms. Grandison will chair the committee

# **District Manager's Report:**

- Change the format of the General Board meeting agenda to comply with the city charter
- Attended meetings with a group of managers, who focus on the future of Community Boards. Met with the Borough President to discuss resources and the lack thereof, training and best practices for CB's . There were emphasis on Administrative support and other issues that impacts community boards and managers. A request for special baseline funding to assist in certain areas.
- Meeting was held with Office of Management and Budget. Concerns were voiced regarding the city agencies consistent responses to Community/budget needs. Managers are seeking a middle ground to improve better participation from agencies.
- Proposed New Location a presentation was made to the Department of Citywide Administrative Service on March 30<sup>th</sup> 2022 and the Notice of Intent to acquire the space at 350 Clarkson Avenue was submitted to the agency.
- Discretionary funds allocated to the committees are being processed as the committees submit their request. Additionally, the Office remains open, members and residents are encouraged to utilize the services the office has to officer.

Brooklyn Borough President - Borough President Antonio Reynoso- greeted those in attendance. He expressed his thanks to the community and his excitement to be the new BP in his capacity to assist community Boards to the level where they feel their participation in community boards is valuable and meaningful. There are high expectations for community boards.

He said he is aware of limited resources for the board and will ask the mayor to increase the funding for community boards, to increase staffing and allow boards to do the work that is very important and necessary in the city.

The BP promised to focus on land use projects and planners to assist community board in navigating land use matters. Assistance from the borough president's office will be extended to community boards.

He said there will be training and information as the office continues to work with community boards. Opportunities will be available to those interested in growing and educating themselves in certain areas of community board work. Training on zoning, text amendment, planning and other courses, such as education communication, health care, transportation, policing etc.

Brooklyn Borough President Antonio Reynoso thanked the Board for having him.

**Question:** Will there be training for Board members, what to do and what to expect, etc.

**Answer:** Yes, there will be an orientation on the basis of the charter mandated responsibilities of

community board members.

• Letter of Recommendation – 67th Precinct's Project Walkway - ADA Compliant

After a lengthy discussion regarding the addition of a ramp to the primary entrance for greater convenience to individuals with disabilities. A request was made to add a stipulation to the letter for a ramp to be installed to allow wheelchair users, strollers, carts, or other wheeled objects to more easily access the entrance of the building.

A motion was made by Mr. Kwame Afreh "I'd like to motion to approve a letter of recommendation for the 67<sup>th</sup> Precinct project walkway. Um, which is trying to bring them up to ADA compliance and also add, added stipulations and concerns to that letter of recommendation". **Motion was second by Mr. Rodrick Daley.**

• LandUse Expansion of Authority – to handle landmark approvals, denials and/or Abstentions at the committee level without Board's approval.

There were concerns regarding giving the committee power over the Body (the Board) will set a very bad precedent.

Mr. Kwame Afreh made a motion to expand the Land Use Committee powers to handle future approvals, denials and extensions related to landmark related renovations without board approval with limitations to doors and limited to doors and Windows.

With no one seconding the motion, the motion was defeated.

**Stephanie Sinn-** Brooklyn Public Library – Updates - Rugby Branch Library.

Technology programs for adults and indoor programming for children has resumed, such as story times for children as well as grab-and-go, crafting, etc.

- COVID tests kits distributed for fee
- Library Laptop loan program has started, need a library card to take a laptop to use in the library
- Outdoor seating will be placed on the sidewalk in front of the building approximately 4 tables and chairs on either side of the door to be used while waiting for the library to open.
- Wi-Fi has been extended to the outdoor tables, and can be used when the branch is closed.
- Summer reading returned for all ages, commences on June 4<sup>th</sup>
- Summer meals will be served after school ends, to ages 18 and younger free of charge

**Mr. Orlando Ross** – Contextual Zoning meeting was held. A survey will be circulated throughout the community to get a better understanding what the community would like to see as it pertains to rezoning. Everyone was asked to participate.

## **Community Session:**

**John Williams** – Requested a letter of Support for Island Of Flatbush Diabetes Task Force. The project was extended to the Central Brooklyn Diabetes Taskforce partners with the Borough president where hundreds benefited from the programs.

He is in the process of launching a campaign and need the support of the Board.

**Leonie Logan,** Vice President of the 67<sup>th</sup> Precinct Community Council, on behalf of President Patricia Reddock – All were invited to the virtual general zoom meeting on April 21<sup>st</sup> at 7:00 p.m. Information in the chat

**Ms. Keira Sutton-Agnew** from Brownsville health action center reported, on May 11<sup>th</sup>, they will be hosting a mental health awareness event at the action center, located at 258 Bristol street from 11:00 a.m. to 3:00 P.M. Event consist of meditation group movement, Individual Sessions, some handouts on medical health providers in the community, cleansing and a few other activities. **Ms. Kamara Jackson** Executive Director of Elite Learners announced 2 spring festivals in partnership with Councilmember Louis, on May 24<sup>th</sup>,. Additionally, Healthy eating initiative, by way of the community pantry is held every Tuesday at 11:00 am. Fresh fruits, vegetables and herbs. More information in the chat.

Mr. Tyrone McDonald – Neighborhood Housing Services of Brooklyn made the following announcements:

- Home repair grant program for disabled Brooklyn veterans. Up to \$20,000 that can be used to assist veterans to do repairs to their homes to make it more comfortable and accessible.
- Property Management program to assist landlords with the management of their property. Must live in the catchment District.

**Ms. Diane Nelson**, Executive Director - Hope Center Development Corporation - a community based organization located at E 409 East  $95^{th}$  Street with a weekly food pantry and soup kitchen serving over 74,000 clients over the last year.

Request for a letter of Support as the Church endeavor to renovate and utilize a building that formerly house the Gail Academy daycare center, to provide a larger space for the distribution of food supplies, in doing so, the community will be intentional about addressing the need of hunger in the district. The space is also wheelchair accessible.

Questions were asked as to why the presentation was not made, first to the Social Services committee in addition to program located next to a one family structure on a residential block.

The Chairperson said the request will be addressed during the Special Report section.

**Sabrina Dieujuste** – Councilmember Louis's office made the following announcements:

**Ezra Pean** – Councilmember Darlene Mealy's office announced:

## **Assembly Member Brian Cunningham reported:**

- He was recently elected to the Assembly and was successful in getting to Albany and passing a late budget.
- Staff member Naomi will bring everyone up to date on the office hours including Saturdays and Sundays. The office is located at 330 Empire Boulevard and has the same telephone number as the former predecessor. There may be a shift in the office location in July.

**Ms. Portia Edwards** – Senator Zellnor Myrie reported the Senator is in the District this week and he has been very busy. She also made the following announcement:

- A "Know Your Public Utility" session was held. The cost of Public Utility went up at the beginning of the year. The session focus on how to protect your right as a consumer. Anyone experiencing a surge in their bill make a complaint to the Public Service Commission 800-342-3377. Residents are encouraged to register their complaint so the laws in place can be changed.
- There are a few laws in the City Council under consideration that the Senator supports.
- The office has a community litter pick-up. The office would like to collaborate with CB17 for the next initiative.

The office continues to give-away test kits, anyone interested, stop by the office Monday through Thursday between 10:00 A.M. and 6:00 P.M. multiple kits are also available. On Fridays, the office is closed to constituents. The office number is 718-284-4700.

Presentation – David Mandel, Community Liaison, Public Art NYC Department of Cultural Affairs.

Mr. Mandel informed the everyone, he will be presenting on the upcoming public artwork commission that will be coming to CB1`7's District as part of the Shirley Chisholm Tourism recreational center capital project. Also, on hand were representatives from the Department of Design and Construction attending on behalf of the Parks Department. They were there to answer questions regarding the larger project.

The community could be involved in the public artwork aspect of the center. The law states 1% of capital funds for newly constructed or reconstructed city building must be allocated for works of art. This helps to employ artist as part of the construction process in New York City, which ensures art is distributed amongst our neighborhoods.

Two panelist were established to review the work of artist. Panelist are representatives from the various agencies and cultural affairs with expert knowledge in public arts in communities where projects are located.

Anyone interested in participating on the panel could contact the community board.

# **Special Report** – Board Members

Ms. Janice Reid followed up on the two items brought before the Board:

• Letter of Support for Hope Center.

Ms. Janice Reid made the following motion: "I would like to put a motion to the floor that a letter of Support be granted to Hope Center Development Corp. to submit the grant application to renovate the church owned building located at 410 East 95<sup>th</sup> Street. The motion was second by Ms. Mary Bell-Downes.

There was a question regarding residents on the block being notified of the proposed new location.

With the absence of Ms. Nelson at the meeting and unable to answer the question, the members voted - 3 - Yes and 16- Abstentions.

The Chairperson said the motion failed to past.

Ms. JL James asked for the BP's office to be contacted. She said the motion was passed. Abstentions do not count.

• Letter of Support – New Creation Community Health Empowerment Inc. (NCCHE)

Ms. Janice Reid made the following motion: I would like to make a motion to grant a letter of support to New Creation Community Health Empowerment Inc. to conduct the National Diabetes prevention workshop sites within the community." The motion was second by Ms. Mary Bell-Downes.
