## **District Manager's Report:**

- Looking forward to getting some assistance in the office and having an assistant district manager.
- We have no new information regarding our new location. We do have a location thanks
  to the new administration and now we are looking to move into 1107 Rogers Ave. We
  have signed the contract and we are waiting on the landlord to sign off. Then we will
  start the build out which would probably take us another couple of months.

## Parks & Beautification: Berlotte Antoine-

## **Agency Report:**

# Rugby & East Flatbush Library Branches – Stefanie Sinn & John Huth

- Recently Libraries received a 5% budget cut and we cut Sunday service and cut our collections spending. We are also facing another 5% cut, but we will not know until January.
- The best way you guys can help the library is by coming in and we are still having many programs for children.

## 67th Precinct:

• We are down 6% year to date, over 130 crimes, were down 5 and 7 majors and down 7 shootings. We have made over 175-gun arrests, so that is 135 guns taken off the street.

## **Community Session:**

Cassandra Jean-Baptiste: The current issue is the smoke shops that have clogged up our community and there are three of them on a three-block radius. There is also a 24 hour one on Church Ave. There are a lot of children who are coming in and smoking in the buildings. We don't feel safe, people are coming in our buildings and smoking, they will leave when we ask but they keep coming in.

**June Persaud** answers: Smoke shops are operating in the fact that they are selling legal items that doesn't require a cannabis license, so they are operating on a thin line. We have reported them many times. We can only do enforcement if they are selling weed without a license. The illegal establishment cannot be within the legal establishment. We have not passed any legal cannabis application in CB17 area.

**Hazel Martinez:** What is the board and the police doing about all these mobile homes? Ms. Fraser has already submitted the complaint and will follow up with the precinct to get the update with what they are doing about it.

**Ms. Cook:** The time is too short for a community to voice their concerns for a community board meeting.

**Asshur Cunningham:** At next month's meeting Ms. Cook will be first to voice her concerns during the community session and Miss Douglas will also we prioritized to voice her concern at the next meeting.

# **NYC Department of City Planning:**

- City of Yes for Economic Opportunity: Second of three City of Yes Initiatives.
- This proposal is the to get zoning out of the way of establishing and expanding businesses.
- Our proposal includes removing the 2-year time clock for reoccupation, simplifying
  district types, enable more small scale production, remove unnecessary loading docks,
  allow commercial uses on upper floors, modernize use terms, add urban agriculture,
  allow regulated licensed labs, address rules pertaining to nightlife and add amusements,
  allow home occupations promote better ground floor design, reduce conflict with auto
  repair, enable micro-distribution facilities and create campus commercial spaces, create
  corner stores, adapting spaces for industries, add new loft style zoning districts.
- Existing conditions in Community District 17: 23,200 jobs, 108% pre covid jobs have been recovered, 2750 storefronts, 280 vacant (10%).
- Timeline: Accepting CB recommendations and want comments by February and give us the feedback within the timeline.
