- All elected officials or representatives please come in person and not online.
- Participatory budget process is upon us.
- Next month all committee chairs will be presenting the action plan for the remainder of the year.
- All committee members will be scheduled events on the nights of their committee.
- Next month meeting will be Wednesday, November 15.
- Official Groundbreaking for Shirley Chisholm Center was on Monday and expected completion date is 2025.

# District Manager's Report:

- Official Groundbreaking for Shirley Chisholm Center was on Monday and expected completion date is 2025 and it was well attended.
- Received call about construction work done by the Department of Design and construction. They are building some Bio swells on Albany Avenue, Linden Boulevard, Lenox Rd, Church Ave, Utica Ave, and Troy.
- I am looking to hold a cabinet meeting soon so please complete the forms so I can hear what you have to say.
- The Capital projects are items that last at least 5 years and costs at least 35,000.
- We are still accepting resumes for the assistant district managers and will begin interviews soon.

#### Public advocate: Jumaane Williams

• The 1st meeting, which was here at CB17 talking about the churches and community center. We got the 1st seed money 500,000 dollars from Mayor Bloomberg.

#### Committee Reports:

**Budget: Dan McCabe** – Unclear of what was said in the first two minutes is due to technical issues. If anyone on the board is interested in helping with the budget, either a standing member or new member, you can contact me, and I wanted to say hello and thank you for the opportunity.

**Commerce: June Persaud-** The commerce committee meets on the third Tuesday of every month and in our meeting was last night we had a representative from booking Chamber of commerce who was our guest speaker and discussed how business can be how businesses can become members of the Brooklyn Chamber of commerce. Our next event scheduled is a small Business Expo on November 18 at 1300 Royal Terrace located at 1298 Utica Avenue from 1 to 5PM. This event is made up of small vendors, selling their products. Our next meeting is November 21st. Cannabis application requests are coming to the board office. We had 3 applications, 2 for the same address, which was withdrawn and 1 for another address which was a no show. It is similar process to the liquor application. A licensed dispensary will not be approved in the location if it's within 500 feet from a school and 200 feet from a house of worship. The guidelines for a license dispensary to another is 1000-2000 feet depending on the population. The agency that handles the cannabis application is, OCM.

Second report: We are in communication with regarding the move to the new location, which is 1107 Rogers Avenue. This is a lengthy process, and the chairs signed the draft document which is the scope of work for landlord and tenant. If the scope of is approved the next step is to sign the lease, which can take about another year. Approval was granted by the landlord for us to take all 3 of our signs to the new location. They also advise us that there is another person interested in the space, though there might be a possibility that we can lose the space.

**Parks & Beautification: Berlotte Antoine-** Our last meeting was on October 7, where we had a presentation by the Department of Sanitation on leaf and yard waste mandatory separation as you all know the curbside composing is expanding. The event on October 14<sup>th</sup> was cancelled due the rain, it will be rescheduled. Our next meeting is on November 14, because the election day is on November 7th. During that meeting we'll have a presentation on the artwork for the conceptual design for the Shirley Chisholm Center.

**Housing & Block Associations: Pearlene Fields-** Since we've been combined, we've changed the dates that we meet. We no longer meet on Thursdays, and we now meet on the 1st, Wednesday of each month. We planned out almost a full year so that we can have some good meetings/ housing series. We're working with Mr. McDonald from NHS. Topics include estate planning, how to protect your property when construction or renovation is happening next to you, understanding your deed and ways to pass down ownership homeowners/renters'

insurance and tenants' rights. If you have something that you would like to add to the series, please feel free to email me.

**Public Safety and Transportation: Ozni Lewis-** Last month I went to the 67<sup>th</sup> precinct community council and learned about the efforts done over Labor Day weekend. One of the most important things that has been brought to my attention is the Interborough Express which would be from Corona to Sunset Park Brooklyn. This new Express has people looking over in terms of land layout, and what are the different obstacles. Meetings are held every 4<sup>th</sup> Wednesday of the month.

**Social and Health Services: Monzurat Oni** – We meet on the 4th, Monday of every month on Webex and right now we are in the planning stages for our spring health fair. We are also looking for ideas to do some online health outreach before the spring. Our next meeting will be next week, Monday, October 23rd at 730 PM and we will have a representative from 1 Brooklyn health to talk about some of the changes that are happening within the hospital system.

**Personnel: Rose Graham** - We continue the task of replacing the assistant district manager and as soon this this training gets underway, we will proceed with the interview process.

**Land Use: Kwame Afreh-** On Thursday October 6<sup>th</sup> we held our meeting and there were some discussions further speaking about the 3002 property and the consensus at the meeting is that we're opposed to it unfortunately, but they will be at the meeting next month to give a presentation. There was also a further conversation on the vital Brooklyn project, and I have the chair of Community Board 9, Mr. Baptiste, he's going to address the letter that he drafted and just give clarity to the community on what their position is.

\*Mr. Baptiste: Last month, we voted to send a letter to the governor saying that we were opposed to this project, because we feel that there was more conversation that needs to be had with the community directly in terms of addressing some of these issues. If there's a project scope change that has happened, making sure that everyone is up to date with that and ensuring that if there are services or resources being brought into the communities that they are sufficient to make sure that all the needs are addressed and that resident needs are addressed. We aren't necessarily saying that no, we are opposed to the project, but we want to make sure that the community needs are being heard and respected and responded to as well.

**Postal Services: Kendrick Westcott**- The post office on Lenox and Utica Avenue has a leak in the ceiling. We called the senator/ councilmember, and they will get back to Ms. Fraser and hopefully they will get back to us soon.

**Communications: Tamara Thomas-** Our YouTube channel is set up and all meetings are on there. Our handle is @BK Community Board 17, or you can visit our website and find all the community meetings there. I just wanted to make a quick correction about something the chair said earlier each committee does have a page where the information on the page is static information. It's not dynamic. It's not changing every month. Social media access is still an

ongoing issue. It was brought to my attention a couple of months ago that the accounts are being used outside of CB17 purview. So, we're going to be working to reclaim those accounts.

Rezoning: Julia James- Yields Time.

**Bylaws: Julia James-** Several issues that we brought to the table in terms of amending the bylaws, the secretaries' duties need to be amended because we have a different process right now and the way the minutes are taken as well. Voting needs to be clarified, excused absences also need to be clarified. there was discussion about amended article 2, which deals with the rotation of board members when we changed the tenure of the officers, we did not correct the act, that the officers can only serve for 4 years. So that needs to be addressed as well. The issue of qualification of officers also came up that if someone is going to be an officer of the board that they need to live in the district, that way, they have a vested interest. The way that the appointment of chairpersons of the board, or the Committee's take place is also being reviewed. Currently the chairperson does that, so other consideration is whether it should be collectively done by the officers.

**Brookdale CAB: Janice Reid-** Just an update regarding announcement that I made last month The cap fundraiser that was scheduled for tomorrow Thursday, October 19 has been canceled. The plan is to offer it again in 2024.

Sanitation & Environmental Services: Michael Hill- If there's anyone out there that sees any issue regarding sanitation, it's been encouraged through Ms. Cunningham that a report be made through 311 and to establish a complaint number so she can speed the issue. However, since Monday's meeting, I have attempted to reach out to Ms. Cunningham, but her voicemail is not active. I speculate that perhaps Miss Cunningham may not be the most effective person. I've heard that she's been aware of several issues before I became chair this committee. I'm going to reach out to Miss Cunningham again and hopefully we'll be able to contact her and deal with these issues. If not, there may be something more that's going to need to be done.

#### **MOTIONS:**

**PRESENTATION: Julia James:** The rezoning committee is presenting the framework for a proposal for zoning for housing, preservation, and equity. For over 17 years, Community District 17 has been calling for housing equity and fairness since we were not permitted to rezone. The mayor's City of yes for housing opportunity acknowledges the fact that there has been less equity. Because what has been happening here is a systematic disenfranchisement of community board 17 that is increasing the racial gap, racial wealth gap, displacing tenants and threatening existing affordable housing.

**ISSUE:** The issue is that there are areas massive areas in our community where developers as a matter of right are able to construct without coming to the community board and as a result of that, a lot of our homes are being destroyed. The current zoning and district 17 does not call for any affordable housing.

**RESOLUTION:** To accept the zoning proposal that has been presented to rezone district 17 and to provide for more housing while as the same time, preserving the homes in the district.

**BE IT RESOLVED,** that to address the city's housing crisis d the inherent problems stemming from developers as of right under the current R6 zoning that CB17 submit a rezoning proposal to the Department of city planning DCP to amend CB17 zoning text and zoning map to facilitate the creation of an additional 3,645 housing units which exceeds the threshold advocated by New York NYC and New York State for community boards.

**BE IT FURTHER RESOLVED**, that Community Board 17 accept the Framework for Zoning and Housing Preservation Proposal – October 18,2023 and as the next step engage in community outreach to inform community residents of the Proposal and to obtain their feedback.

-The vote tonight will be to accept the zoning proposal which was presented to the board members back in September as well as submitted by email currently.

\* It does not need to be 2nd, because this is a resolution coming out of committee.

<u>Marguerite Vigilante</u> rises to oppose the resolution based on the zoning on the map (within presentation). There is too much up zoning on the map and the current proposal resolution gives away too much.

<u>Tamera Thomas</u> speaks in favor of the resolution. <u>Rodrick Daley</u> speaks in favor of the resolution.
