<u>Call to Order:</u> This meeting of the Land Use Committee Meeting was called to order by Kwame Afreh at 7:30pm.

Chairperson's Report:

- Welcome everyone back.
- There was a city-wide closer of smoke shops by a joint task force with the sheriffs department.
 - Some opened back up but were promptly closed soon after.
 - o If anybody sees a smoke shop, feel free to communicate with Chair Afreh.
 - Now the issues is what to do with the many shuttered businesses.
- There was an explosion on August 29th, on 37 Street.
 - No casualties but the cause of the explosion seems to be a leak from the basement stove.
 - Notices have been sent out to inform homeowners of identifying gas leaks and how to report it. These notices will be shared after the meeting.
- 5604 Ave which has been in development, will provide units designated to senior citizens.
 - Mondoc sent an informal variance permit to start 30 earlier then they are approved, to reduce pedestrian traffic and increase safety for the community.
- Sherley Chisom Recreation Center's construction has been ongoing but there has been very little communication regarding the workforce and contracting opportunities since the beginning of summer.

Approval of Meeting Minutes:

Lack of quorum so minutes were not approved.

Unfinished Business:

- Concerns have been raised about the construction of the Shirley Chisom Recreation Center and its impact on residents.
- Cameras installed in the community for surveillance should be used and enforced to address the issue of garbage dumping.
- National Grid inspection was conducted and if everything is fine, they won't inspect again for five years.
- Concerns raised about the safety of a boarded-up car wash and loud parties in the neighborhood.
- A concern was raised about submittion of the City of Yes letter being sent out late.

New Business:

- Follow up on the complaints regarding the car wash on Farragut Road and Utica Avenue, including noise, trash, and the vacate order
- Members are encouraged to attend the IBX meeting on September 16th.

For Review:

- 3002 Farragut Rd
 - Proposed 8 parking spots and the revised proposal is asking for more parking spots.
 - This is an application for a special permit pursuant to Section 73-44 and Section 73-03 of the Zoning Resolution of the City of New York ("ZR"), to reduce the total number of required accessory off street parking spaces for a six (6) story with cellar, proposed Use Group III(B) ambulatory diagnostic or treatment facility use from forty-eight (48) to twenty-four (24) spaces in an R6/C1-3 zoning district.
 - Need information about the hydraulic jack systems for parking, the number of staff, etc.
