The Sanitation/DEP Committee Meeting was held on Wednesday, October 21, 2023 at 7:30 p.m. Virtually via WebEx.

Mr. Michael Hill called the meeting to order. He asked everyone to introduce themselves.

Everyone introduced themselves.

Notes

The meeting discussed ongoing complaints about abandoned vehicles, parking difficulties, garbage accumulation, uncollected trash, lack of street sweeping, and dumpsters causing issues, with suggestions including compiling complaint numbers and evidence, involving the news for attention, scheduling meetings with sanitation and police representatives for accountability, and potentially involving media attention and community action for a more direct approach to address these issues.

- Michael Hill discusses complaints from the previous meeting, including issues with abandoned vehicles and difficulty finding parking.
- Kenrickk reports on garbage on Clouden Road and cars without license plates on 52nd Street.
- Hazel Martinez raises concerns about lack of improvement in response to complaints, including uncollected garbage, street sweeping not being done, and dumpsters causing issues.
- There are complaints about trucks not properly cleaning the streets in the community.
- The group discusses compiling complaint numbers and providing evidence with pictures to the commissioner.
- There is a suggestion to get the news involved to bring attention to the issue.
- The group also discusses the lack of enforcement by traffic agents and suggests scheduling meetings with both sanitation and police representatives for accountability.

- There is a discussion about the responsibility of the Department of Sanitation in cleaning up the neighborhood and addressing trash issues.
- There are complaints about trash accumulation in certain areas and concerns about the effectiveness of the Department of Sanitation's schedule.
- The meeting participants discuss the need for a more direct approach, potentially involving media attention and community action, to address these issues.
- Jadeeva Smith suggests placing trash cans on residential streets in addition to commercial streets for convenience and to reduce littering.
- JL James CPA suggests that bins should be placed on residential streets by request only, rather than being placed everywhere.
- Leoni Logan cautions against placing bins in residential areas based on past experiences of overflowing and misuse.
- The meeting is focused on addressing ongoing complaints and issues.
- Michael Hill, the new chair, expresses the need for action and a change in approach to resolve the problems.
- Hazel Martinez and Vanessa Quashie highlight the lack of progress in resolving complaints over the years.
- There is a discussion about reaching out to sanitation, attending meetings, and taking personal initiatives to address the issues.
