Civilian Complaint Review Board

The New York City Civilian Complaint Review Board (CCRB) is an independent agency. It is empowered to receive, investigate, mediate, hear, make findings, and recommend action on complaints against New York City police officers alleging the use of excessive or unnecessary force, abuse of authority, discourtesy, or the use of offensive language. The Board's investigative staff, composed entirely of civilian employees, conducts investigations in an impartial fashion. The Board forwards its findings to the police commissioner. The CCRB investigates complaints about four types of misconduct by sworn officers of the NYPD: force that is excessive or unnecessary; abuse of authority; discourtesy; and offensive language. The CCRB does not investigate the actions of civilian employees of the NYPD such as school safety officers or crossing guards.

The Outreach & Intergovernmental Affairs Unit informs and educates the public about:

- The structure and authority of the CCRB
- Civilians' rights and responsibilities during police encounters such as question-stop-and-frisk
- De-escalation
- How to file a complaint
- The investigation and mediation process
